A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DETERMINING THAT THE INSTALLATION OF TWO SMALL PRE-FABRICATED RESTROOM STRUCTURES IS CATEGORICALLY EXEMPT FROM THE CALIFORNIA ENVIROMENTAL QUALITY ACT PURSUANT TO EXEMPTION GUIDELINE 15303.

WHEREAS, the Downtown Restrooms (Portland Loos) Project requires the installation of two small pre-fabricated restroom structures; and

WHEREAS, the California Environmental Quality Act (CEQA), Public Resources Code section 21084, states that the CEQA Guidelines shall list those classes of project which have been determined not to have a significant effect on the environment and which shall be exempt from CEQA; and

WHEREAS, pursuant to that authority, CEQA Guidelines sections 15300-15333 list the categorical exemptions promulgated by the California Office of Planning and Research for those classes of projects which have been determined not to have a significant effect on the environment; and

WHEREAS, the Council of the City of San Diego (City Council) has considered the potential environmental effects of installing two small pre-fabricated restrooms; and

WHEREAS, the City Council considered the written record for the project as well as public comment; and

WHEREAS, the City Council, using its independent judgment, has determined that the project will not have a significant effect on the environment because the installation of the new facility is in a small structure; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego as follows:

- The Downtown Restrooms (Portland Loos) Project, which consists of installing two small pre-fabricated restrooms, is categorically exempt from CEQA pursuant to CEQA Guidelines 15303.
- 2. An exception to the exemption as set forth in CEQA Guidelines 15300.2 has been determined not to apply.
