A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO TO APPROVE THE SETTLEMENT OF THE MATTER OF IRENE MCCORMACK JACKSON V. CITY OF SAN DIEGO, ET AL.

WHEREAS, on July 22, 2013, Irene McCormack Jackson filed suit titled *Irene McCormack Jackson v. City of San Diego and Robert Filner*, San Diego Superior Court Case No. 37-2013-0058613-CU-OE-CTL and on August 1, 2013, the City Attorney's office filed an answer thereto on behalf of the City of San Diego and on September 3, 2013, the City Attorney's office filed an answer thereto on behalf of Robert Filner;

WHEREAS, in closed session on February 10, 2014, the City Council, by unanimous vote, approved settlement of the Litigation pursuant to such terms more fully set forth in the Settlement Agreement;

WHEREAS, pursuant to the settlement the City agreed to pay the sum of Two Hundred Fifty Thousand Dollars and Zero Cents (\$250,000.00) to McCormack Jackson in exchange for McCormack Jackson's dismissal of all claims against the City and Filner;

THEREFORE, NOW BE IT RESOLVED, by the Council of the City of San Diego that the Council authorizes:

1. The sum of Two Hundred Fifty Thousand Dollars and Zero Cents (\$250,000.00) to be paid from the Public Liability Fund in settlement of each and every claim for damages, interest, costs and fees of any type, including attorney fees, against the City, Filner, their agents and their employees, arising from the Litigation;
