A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AMENDING COUNCIL POLICY 900-15
“SMALL BUSINESS ENHANCEMENT PROGRAM (SBEP)”

WHEREAS, the City Council is charged with the responsibility of establishing municipal policies to guide the various functions of the City, and where necessary, to establish procedures by which functions are performed; and

WHEREAS, the purpose of the Small Business Enhancement Program (SBEP) was to provide continuing support to small businesses in recognition of their vital economic, employment, service, and cultural roles, and their importance in sustaining and revitalizing older commercial and residential areas; and

WHEREAS, Council Policy 900-15 “Small Business Enhancement Program (SBEP)” was scheduled to sunset five years from its adoption on November 13, 2008; and

WHEREAS, on November 6, 2013, the Council Committee on Rules and Economic Development (Committee) reviewed the proposed revisions to Council Policy 900-15 and voted unanimously to forward the revised Council Policy to the City Council for its consideration; and

WHEREAS, additional revisions were made after the Committee’s consideration to reflect changes to the language as directed by the Committee; and


WHEREAS, additional substantive and non-substantive revisions were made after the Committee’s consideration for legal compliance, clarity and consistency; and

WHEREAS, the revised Council Policy 900-15 will ensure that SBEP continues in operation and will address certain management and budgetary aspects of SBEP; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, as follows:

1. The Council hereby adopts the revisions to Council Policy 900-15, as set forth in the Document No. RR- ~~308776~~ filed in the Office of the City Clerk.
2. The City Clerk is instructed to update the Council Policy Manual to include the revised Council Policy 900-15.
