A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO DECLARING THE RESULTS OF THE
SPECIAL RUN-OFF ELECTION IN THE CITY OF
SAN DIEGO ON FEBRUARY 11, 2014, TO FILL THE
OFFICE OF MAYOR

WHEREAS, a Special Run-off Election was held in the City of San Diego on Tuesday, February 11, 2014, pursuant to the provisions of Ordinance No. O-20334 (New Series), introduced and adopted on December 17, 2013, for the purpose of electing a Mayor to fill the remainder of the four-year term previously held by Bob Filner, who resigned from the office in August 2013; and

WHEREAS, a copy of the certificate of the Registrar of Voters of San Diego County (Registrar of Voters) canvassing the returns of the Special Run-off Election, as certified to the City Clerk, has been duly received; and

WHEREAS, the City Clerk has certified the results to the City Council; and

WHEREAS, declaring the results of the election as certified by the Registrar of Voters and the City Clerk is a ministerial act required by California Elections Code section 10263 and, therefore, is not subject to veto by the Mayor; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Council finds and determines, pursuant to the provisions of Section 27.0411 of the San Diego Municipal Code, as follows:

I

The total number of votes cast in the Special Run-off Election was 294,491.

II

The results of the canvass of the votes cast in the Special Run-off Election held on Tuesday, February 11, 2014, and certified by the City Clerk, are as follows:

FOR THE OFFICE OF MAYOR

(Filling the vacancy in the four-year term previously held by Bob Filner, who resigned, and expiring in December 2016):


KEVIN FAULCONER	153,491 VOTES (52.89%)
DAVID ALVAREZ	136,701 VOTES (47.11%)
Total	290,192 VOTES (100%)

Kevin Faulconer is hereby declared to be elected to the Office of Mayor in the Special Run-off Election, to fill the remainder of the current four-year term.

The City Clerk shall make public the results of the canvass of the Special Run-off Election by publication of a copy of this resolution.


