WHEREAS, during the Fiscal Year 2014, the Commission conducted extensive research and held a series of public hearings to determine and ascertain facts sufficient to establish salary levels for recommendation to the Mayor and Council for adoption by ordinance as required by the Charter; and

WHEREAS, the Commission pursuant to the mandate of the Charter, presented its recommendations in a report dated February 7, 2014 to the Mayor and Council; and

WHEREAS, the Commission recommended the annual salary for the Mayor and City Council as follows:
