DATE OF FINAL PASSAGE APR 3 2014

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING EXECUTION OF OPTIONS TO EXTEND THE CONTRACT WITH JCI JONES CHEMICALS, INC. FOR LIQUID CHLORINE FOR FOUR ADDITIONAL ONE-YEAR TERMS; AND TAKING RELATED ACTIONS.

WHEREAS, JCI Jones Chemicals, Inc. is providing the City of San Diego with liquid chlorine for use in disinfection of water at the Alvarado, Miramar and Otay Water Treatment Plants pursuant to Contract No. 4600001365/RFB No. 10025736-12-C (Contract); and

WHEREAS, the Contract was originally for a one-year term beginning July 13, 2012, but has renewal options for four additional years, with provision for an annual price increase not to exceed 7 percent; and

WHEREAS, continued and additional purchases under the Contract will result in expenditures exceeding \$1 million, thereby requiring City Council authorization; NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor, or his designee, is authorized to execute the four one-year contract extension options under the Contract, contingent upon adoption of the Annual Appropriation Ordinance for the applicable fiscal year and provided that the Chief Financial Officer first furnishes one or more certificates demonstrating that the funds are, or will be, on deposit with the City Treasury.

2. That the Chief Financial Officer is authorized to expend an amount not to exceed \$2,952,901 over four fiscal years from the Water Utility Operating Fund 700011 (\$690,370 in

Fiscal Year 2014; \$703,760 in Fiscal Year 2015; \$753,024 in Fiscal Year 2016; and \$805,747 in Fiscal Year 2017) for the purpose of funding the above Contract, provided that the Chief Financial Officer first furnishes one or more certificates demonstrating that the funds are, or will be, on deposit with the City Treasury.


