A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR TO EXECUTE THE CONSULTING AGREEMENT WITH RBF CONSULTING FOR THE PREPARATION OF THE LINDA VISTA COMPREHENSIVE ACTIVE TRANSPORTATION STRATEGY.

WHEREAS, in 2012, the City of San Diego received a \$300,000 Active Transportation

Grant from the San Diego Association of Governments (SANDAG). The funds were awarded for a Comprehensive Active Transportation Strategy (CATS) within the Linda Vista Planning Area to engage residents to develop a plan for a network that encourages active (multi-modal) transportation by providing direct connections for residential areas, schools, employment centers, transit stations, public places, retail, and community destinations. The CATS will provide detailed recommendations for active (multi-modal) transportation improvements within the Linda Vista community; and

WHEREAS, despite the auto-centric nature in the Linda Vista community, many residents use public transportation, walk, and bike to various community destinations; and

WHEREAS, the goals of the Linda Vista CATS include creating a complete network that provides direct and convenient connections, to increase pedestrian and bicycle safety, and to identify high priority innovative pedestrian and bicycle projects for implementation; and

WHEREAS, to create the CATS, information will be gathered from community members regarding any constraints and challenges of traveling through the community, and data from the Bicycle and Pedestrian Master Plans will be used to identify pedestrians and bicyclist attractors and locations that draw in pedestrians/bicyclists into the area; and

WHEREAS, the Department of Planning, Neighborhoods, and Economic Development

determined that a consultant is needed to provide traffic engineering services; and

WHEREAS, the City used the City's Consultant Rotation List process for the selection of

a consultant, and as a result of this process, the City has selected RBF Consulting; NOW,

THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, as follows:

That the Mayor or his designee, is authorized to execute, for and on behalf of the 1.

City, an agreement with RBF Consulting for the preparation of the Linda Vista Comprehensive

Active Transportation Strategy, in an amount not to exceed \$275,245, which is on file in the

office of the City Clerk as Document No. RR-_308818 (Agreement).

2. That the Chief Financial Officer is authorized to appropriate and expend an

amount not to exceed \$275,245 from Fund 600001, Grant 1000406-2013 to provide funds for the

Agreement with RBF Consulting to conduct a Comprehensive Active Transportation Strategy in

the Linda Vista community, contingent upon the Chief Operating Officer certifying that the

funds necessary for the expenditure are, or will, be available.
