DATE OF FINAL PASSAGE APR 3 2014

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DETERMINING THAT THE APPROVAL OF THE CONSULTANT AGREEMENT WITH RBF CONSULTING FOR THE PREPARATION OF THE LINDA VISTA COMPREHENSIVE ACTIVE TRANSPORTATION STRATEGY IS STATUTORILY EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT PURSUANT TO STATE CEQA GUIDELINES SECTION 15262.

WHEREAS, the City of San Diego will consider the approval of a consultant agreement with RBF Consulting for the preparation of the Linda Vista Comprehensive Active Transportation Strategy (Project); and

WHEREAS, the California State Legislature, through the California Environmental Quality Act (CEQA); California Public Resources Code sections 21000 through 21177, has determined that CEQA does not apply to various types of projects listed therein; and

WHEREAS, California Public Resources Code section 21084 states that the CEQA Guidelines shall list those classes of projects which have been determined not to have a significant effect on the environment and which shall be exempt from CEQA; and

WHEREAS, pursuant to that authority, CEQA Guidelines sections 15260 through 15285 list the statutory exemptions promulgated by the California State Legislature; and

WHEREAS, the Department of Planning, Neighborhoods, and Economic Development has established that the Project is statutorily exempt from CEQA pursuant to CEQA Guidelines section 15262 (Feasibility and Planning Studies); and

WHEREAS, the Council of the City of San Diego has considered the potential environmental effects of the Project; and

WHEREAS, on MAR 18 2014, the City Council held a duly noticed public meeting and considered the written record for the Project as well as any public comment; and

WHEREAS, the Council of the City of San Diego, using its independent judgment, has determined that the Project will not have a significant effect on the environment because it only involves an agreement related to the preparation of a plan for possible future actions; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Project is exempt from CEQA pursuant to state CEQA guidelines section 15262.


