BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor or his designee is authorized to execute, for and on behalf of the City, a seventh extension to the agreement with Allan Company for the operation of the Miramar Landfill Recycling Center, retroactive to January 1, 2014, under the terms and conditions set forth in the Seventh Extension to Miramar Recycling Center Service Contract, on file with the City Clerk as Document No. RR 308837.
