(1) small business owner; (2) accounting, financial-lending, legal or economic backgrounds; and

(3) advocates of small business interests with governmental agencies; and

WHEREAS, the Small Business Advisory Board is a Charter section 43 advisory board and the Council is filling a vacancy on the board under the authority granted to it in Charter section 43(c); NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the following appointment by the Council of the City of San Diego, in compliance with Charter section 43(c), to serve as a member of the Small Business Advisory Board, for the term expiring as indicated, is made and hereby confirmed:
