A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO CONFIRMING APPOINTMENTS TO THE WETLANDS ADVISORY BOARD

WHEREAS, the Wetlands Advisory Board (Board) is established in the San Diego Municipal Code under Chapter 2, Article 6, Division 10, to advise the Mayor, City Council and City Manager on public policy matters relating to conservation of wetlands in the City of San Diego; and

WHEREAS, the Municipal Code provides that the Board shall consist of nine members appointed by the Mayor and confirmed by the City Council; and

WHEREAS, the Municipal Code provides that members shall serve three-year staggered terms; each member shall serve until a successor is duly appointed and confirmed; and all terms must have expiration dates of July 1; and

WHEREAS, Board members shall consist of at least one wetland scientist; at least one land use expert; at least one representative with expertise in vernal pools, coastal salt marsh, riparian fresh water habitat and marine resources, with consideration given to geographic diversity; at least one representative from environmental organizations; and at least one member representing landowners; and

WHEREAS, the Board is a Charter section 43 advisory board and the Council is making appointments to the Board under the authority granted to it in Charter section 43(c); NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the following reappointments by the Council of the City of San Diego, in compliance with Charter section 43(c), to serve as members of the Wetlands Advisory Board, for the terms expiring as indicated, are made and hereby confirmed:
