A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING AND DIRECTING THE MAYOR TO EXECUTE AN AGREEMENT FOR SECURITY SERVICES WITH LOCATOR SERVICES, INC., DBA ABLE PATROL & GUARD, FOR THE PROVISION OF SECURITY SERVICES AT VARIOUS CITY FACILITIES; AND AUTHORIZING FUNDING THEREFOR.

WHEREAS, the City of San Diego (City) issued a request for bids (RFB No. 10028480-13-Q) in September of 2012 to furnish the City with security guard services at City facilities in various locations using a combination of roving foot patrols, vehicle patrols, and stationary guards; and

WHEREAS, as later revised to exclude security at Public Utilities facilities, the RFB sought proposers for a one (1) year contract with four (4) one-year options for the provision of security services at the following City facilities: the Central Library and 15 branch libraries, the City Administration Building, the Development Services Center, Balboa Park, the Rose Canyon Operations Yard, the 20th and B Street building, and the Parkade, Concourse, Terrace Plaza and Concourse Plaza at the Civic Center; and

WHEREAS, after a comprehensive review of the twenty proposals submitted in response to the RFB, and after the withdrawal of other bidders, the RFB Selection Committee recommends that Locator Services, Inc. dba Able Patrol & Guard (Able Patrol) be awarded the contract for the provision of security guard services at this time, based on its compliance with the requirements of the RFB, its relevant experience, and its proposed competitive pricing, along with other evaluation factors set forth in the RFB; and

WHEREAS, adoption of the resolution will authorize entering into and expending funds for the first year of the agreement in an amount not to exceed \$1,971,965, with four (4) one-year options to renew, at the sole discretion of the City, at a not to exceed cost (including living wage increases) of: \$2,003,516 for the second option year; \$2,035,572 for the third option year; \$2,068,142 for the fourth option year; and \$2,101,232 for the fifth option year; the renewal of and payment for each option year being contingent upon certification by the Comptroller that funds are available for that purpose; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor, or his designee, is hereby authorized and directed to execute, for and on behalf of the City, that certain contract, on file with the Office of the City Clerk as Document No. R-308850 with Locator Services, Inc., dba Able Patrol & Guard (Able Patrol) for the provision of security guard services at various City sites as set forth therein for a term of one year, with four (4) one-year options to renew at the sole discretion of the City.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is hereby authorized to expend up to \$1,971,965 for the first year (FY14) of the contract (\$1,355,568 from Fund No. 100000; \$141,552 from Fund No. 200308; \$214,464 from Fund No. 700036; and \$280,380 from Fund No. 200300) for the provision of security guard services pursuant to the contract with Able Patrol.

BE IT FURTHER RESOLVED, that contingent upon the adoption of the FY15, FY16, FY17 and FY18 Appropriation Ordinances, and contingent upon certification by the Comptoller that funds have been appropriated and are available for this purpose, and contingent upon the exercise by the City of the relevant option, the Chief Financial Officer is hereby authorized to expend the following amounts for the provision of security guard services pursuant to the

contract with Able Patrol: up to \$2,003,516 for year 2 (FY15), \$2,035,572 for year 3 (FY16), \$2,068,142 for year 4 (FY17), and \$2,101,232 for year 5 (FY18), all from Fund Numbers 100000, 200308, 700036, and 200300, for a total not to exceed amount of \$10,180,426 for the contract.
