BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$242,478 from CIP No. A-AA.00001, Annual Allocation-Montgomery Field (B-00910 MYF Rehab of Runway 5/23 and Taxiway G), Fund 700030 for design consulting services for the Project, under the terms set forth in the First Amendment to the Agreement, solely and exclusively for the purpose of providing funds for the Project, provided that the Chief Financial Officer first furnishes a certificate certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
