A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO FOR THE DEAPPROPRIATION OF THE FOURTH AVENUE AND QUINCE STREET PROJECT AND FOURTH AVENUE/FIFTH AVENUE AND NUTMEG STREET PROJECT FROM THE 2014 CIP BUDGET.

WHEREAS, on May 22, 2009, the San Diego Association of Governments (SANDAG) awarded the City of San Diego (City) grant funds from the FY2009-FY2010 Smart Growth Incentive Program for the purpose of enhancing mobility and safety for pedestrians, bicycles, and access to transit at Fourth Avenue and Quince Street, Fourth Avenue/Fifth Avenue and Nutmeg Street, and Park Boulevard and Essex Street; and

WHEREAS, the City postponed implementation of the Fourth Avenue and Quince Street and Fourth Avenue/Fifth Avenue and Nutmeg Street projects at the request of SANDAG; and

WHEREAS, on April 2013, City staff met with SANDAG and agreed that the best option would be to transfer the management, design, and completion of the Fourth Avenue and Quince Street and Fourth Avenue/Fifth Avenue and Nutmeg Street projects to SANDAG for consolidated implementation with the Uptown Regional Corridor Project and Regional Bicycle Early Action Program; and

WHEREAS, the City has agreed to transfer both projects to SANDAG and to authorize the reprogramming of \$647,901.92 of unspent grant funds associated with these projects; and

WHEREAS, on July 19, 2013, SANDAG's Transportation Committee approved to the reprogramming of the unspent Smart Growth Incentive Program funds; and

WHEREAS, this fiscal action will also reprogram \$30,000 of funding to complete the Park Boulevard and Essex Street Project, where any further discretionary actions will be subject to environmental review; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Chief Financial Officer is authorized to reduce the Fiscal Year 2014 Capital Improvement Program budget by deappropriating an amount not to exceed \$647,901.92 in Fund 600002, Grant 1000310-2010, of which \$140,860.68 is from CIP S-11055, Fourth Avenue and Quince Street, and \$507,041.24 is from CIP S-11056, Fourth Avenue/Fifth Avenue and Nutmeg Street, for the purpose of cancelling and closing the projects; and

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to transfer appropriations of \$30,000.00 from CIP S-11056, Fourth Avenue/Fifth Avenue and Nutmeg Street, to CIP S-11054, Park Boulevard and Essex Street within Fund 400169, TransNet, for project completion; and

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to reduce the Fiscal Year 2014 Capital Improvement Program budget by de-appropriating and returning to fund balance an amount not to exceed \$164,623.37 in Fund 400169, TransNet, of which \$15,869.71 is in CIP S-11055, Fourth Avenue and Quince Street, and \$148,753.66 is in

CIP S-11056, Fourth Avenue/Fifth Avenue and Nutmeg Street, for the purpose of cancelling and closing the projects.
