That the Mayor, or his designee, is authorized to execute an Agreement with RBF Consulting for As-Needed Engineering and Consultant Services to support the City's Storm Water Program (Agreement), for an amount not to exceed \$21,250,000 over five (5) years, under the terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR-308876.

That the Chief Financial Officer is authorized to expend an amount not to exceed \$21,250,000 over five (5) years for services under the Agreement, contingent upon the City Council's approval of the Appropriation Ordinance for the applicable fiscal year, and the Chief Financial Officer demonstrating that the funds necessary for expenditure are, or will be, on deposit with the City Treasury.

3. That the Chief Financial Offic	er is authorized to expend \$1,000 from
Fund 100000 - General Fund, Transportation	& Storm Water Department operating budget, for
