A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPOINTING THE FISCAL YEAR 2015
ADVISORY BOARDS FOR THE BUSINESS IMPROVEMENT
DISTRICTS.

WHEREAS, the City Council, in accordance with the Parking and Business Improvement Area Law of 1989 (California Streets and Highways Code sections 36500, et seq.) and City Council Policy 900-07, wishes to continue the promotional activities of eighteen Business Improvement Districts identified below (Districts) in the City of San Diego; and

WHEREAS, California Streets and Highways Code section 36530 and Council Policy 900-07 require the City Council to appoint a business or merchants association (Association) for each of the Districts as an advisory board, which among other things, provides recommendations to the City on the expenditure of assessment revenues; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that pursuant to California Streets and Highways Code section 36530 and Council Policy 900-07, the following organizations are hereby appointed as the Associations and advisory boards for their respective Districts for period of July 1, 2014 through June 30, 2015:




