A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE FISCAL YEAR 2015 BUDGET REPORTS FOR THE SPECIFIED BUSINESS IMPROVEMENT DISTRICTS.

WHEREAS, the City Council, in accordance with the Parking and Business Improvement Area Law of 1989 (California Streets and Highways Code sections 36500, et seq.) and City Council Policy 900-07, wishes to continue the promotional activities of specified Business Improvement Districts in the City of San Diego; and

WHEREAS, California Streets and Highways Code section 36530 and Council Policy 900-07 require the City Council to appoint a business or merchants association (Association) for each of the Districts as an advisory board, which among other things, provides recommendations to the City on the expenditure of assessment revenues; and

WHEREAS, the respective Fiscal Year 2014 Associations for each of the following Business Improvement Districts has submitted a report (Budget Report) for the period of July 1, 2014 through June 30, 2015 (Fiscal Year 2015), as required by California Streets and Highways Code section 36533: Adams Avenue; City Heights; College Area; Diamond; Downtown; East Village; El Cajon Boulevard Central; El Cajon Boulevard Gateway; Gaslamp; Hillcrest; La Jolla; Little Italy; Mission Hills; North Park; Ocean Beach; Old Town; Pacific Beach; and San Ysidro; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, as follows:

- 1. The Fiscal Year 2015 Budget Report for each of the following Districts, as further described in paragraph 2 of this Resolution, is hereby approved: Adams Avenue; City Heights; College Area; Diamond; Downtown; East Village; El Cajon Boulevard Central; El Cajon Boulevard Gateway; Gaslamp; Hillcrest; La Jolla; Little Italy; Mission Hills; North Park; Ocean Beach; Old Town; Pacific Beach; and San Ysidro.
