BE IT RESOLVED, pursuant to Section 9.1 of the Fiscal Year 2015 Salary Ordinance, that the City Council approves the job classifications in the City of San Diego's Classified Service that are eligible for premium or regular rate overtime compensation, effective July 1, 2014 through June 30, 2015, which are set forth in Personnel Manual Index Code H-4 (Addendum A: Overtime Compensation), which is Attachment A to this Resolution.
