DATE OF FINAL PASSAGE MAY 29 2014

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR TO ENTER INTO A FOURTH AMENDMENT TO THE CITY'S AGREEMENT WITH AVIAT US, INC. FOR THE PURPOSE OF PROVIDING AND UPGRADING THE CITY'S WIRELESS MICROWAVE COMMUNICATIONS SYSTEMS.

WHEREAS, the Communications and Network Services Division of the Department of Information Technology is in the process of upgrading the existing public safety voice radio system to a regional Project 25 interoperable standards-based radio system (P25); and

WHEREAS, the new digital public safety radio system will replace the existing public safety radio system that will reach end-of-life in December of 2016; and

WHEREAS, the total project cost is estimated to be \$21.2 million; and

WHEREAS, as of December 2013, construction of the new P25 radio system is approximately sixty percent complete with costs being paid for through the use of \$13.1 million in federal grant funding awarded to the City via City Council approved grants; and

WHEREAS, Aviat US, Inc. (Aviat) is contracted to furnish wireless microwave systems including infrastructure upgrades and the integration of radio voice and data networks; and

WHEREAS, the original contract enhanced regional interoperability by installing microwave radios on four communication tower sites; and

WHEREAS, subsequent amendments expanded the scope and cost of the original contract with Aviat; and

WHEREAS, the first amendment increased the cost of the original contract by \$69,042.61 and was entered into on December 15, 2011; and

WHEREAS, the second amendment clarified the cost of the contract's performance bond at no cost to the City and was entered into on March 29, 2012; and

WHEREAS, the third amendment was needed to purchase equipment for three additional microwave communication sites, increasing the City's expenditure under the contract by \$153,236.36 and was entered into on December 9, 2013; and

WHEREAS, this fourth amendment will authorize an additional contract expenditure of \$2,712,759 with Aviat for the purchase and installation of microwave equipment that will continue the needed upgrades to public safety radio and data networks; and

WHEREAS, the City has two funding sources available for this fourth amendment; and

WHEREAS, \$212,759 of the expenditure will come from grant funds awarded in 2010 by the Department of Homeland Security, via the State of California, for the Border Interoperability Demonstration Project (BIDP); and

WHEREAS, this portion of the BIDP project will fund two microwave hops for the City's voice radio and data networks; and

WHEREAS, no City funds are required for the \$212,759 of grants funds used for this fourth amendment; and


WHEREAS, \$2,500,000 of the fourth amendment's costs will be debt financed with Bank of America Public Capital Corp.; and

WHEREAS, this \$2,500,000 will provide for replacing end of life microwave radio terminals, 48-volt emergency battery systems, fiber optic cabling, and network management equipment located at regional and citywide communication sites; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the Mayor, or his designee, is authorized to execute a fourth amendment to the Agreement with Aviat US, Inc. to increase the contract amount by \$2,712,759 for a total not to exceed amount of \$3,662,759.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an additional not to exceed amount of \$212,759 contingent upon the Comptroller certifying that the funds necessary for expenditure are available in grant #1000352-2011, fund 600000, cost center 191200011, IO AA1000352-11.


