DATE OF FINAL PASSAGE MAY 29 2014

A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO AUTHORIZING THE ACCEPTANCE OF  
FUNDS FOR THE REDESIGN OF SATURN BOULEVARD  
AND RIMBEY AVENUE SIDEWALK IMPROVEMENT  
PROJECT.

WHEREAS, the proposed Saturn Boulevard and Rimbey Avenue Sidewalk Improvement Project (Project) will widen Saturn Boulevard between Rimbey Avenue and Leon Avenue to its ultimate curb to curb width of forty-eight feet and provide associated improvements in the Otay Mesa-Nestor Community; and

WHEREAS, existing telephone utilities are in conflict with the proposed street improvements to be provided by Project; and

WHEREAS, Pacific Bell Telephone Company has agreed to reimburse the City of San Diego (City) to redesign the Project so that existing telephone utilities will not be relocated;  
NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor or his designee is authorized to enter into an Agreement with Pacific Bell Telephone Company Utilities for the purpose of redesigning the project to accommodate Pacific Bell Telephone Company Utilities in AIK00001, New Walkways (CIP B-10145, Saturn Boulevard & Rimbey Avenue Sidewalk Improvement Project), under the terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR 308934 ; and

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to accept \$40,000 into fund 400264, Private and Others Contributions, from Pacific Bell Telephone Company Utilities; and

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to increase the Capital Improvements Program Budget in AIK00001, New Walkways (CIP B-10145, Saturn Boulevard & Rimbeay Avenue Sidewalk Improvement Project), and to appropriate and expend an amount not to exceed \$40,000 from fund 400264, Private and Others Contributions, for the purpose of redesigning the Project to accommodate existing telephone utilities.
