A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DETERMINING THAT ACCEPTANCE OF FUNDS FOR THE REDESIGN OF SATURN BOULEVARD AND RIMBEY AVENUE SIDEWALK IMPROVEMENT PROJECT IS CATEGORICALLY EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT PURSUANT TO CEQA GUIDELINE SECTION 15304 FOR MINOR ALTERATIONS TO LAND.

WHEREAS, the proposed Saturn Boulevard and Rimbey Avenue Sidewalk Improvement
Project (Project) will widen Saturn Boulevard between Rimbey Avenue and Leon Avenue to its
ultimate curb to curb width of forty-eight feet and provide associated improvements in the Otay
Mesa-Nestor Community; and

WHEREAS, the California Environmental Quality Act (CEQA), Public Resources Code section 21084, states that the CEQA Guidelines shall list those classes of projects which have been determined not to have a significant effect on the environment and which shall be exempt from CEQA; and

WHEREAS, pursuant to that authority, CEQA Guidelines sections15300-15333 list the categorical exemptions promulgated by the California Office of Planning and Research for those classes of projects which have been determined not to have a significant effect on the environment; and

WHEREAS, the Council of the City of San Diego has considered the potential environmental effects of the Saturn Boulevard and Rimbey Avenue Sidewalk Improvement Project; and

WHEREAS, on MAY 1 3 2014 , the City Council held a duly noticed public meeting and considered the written record for the project as well as public comment; and

WHEREAS, the Council of the City of San Diego, using its independent judgment, has determined that the project will not have a significant effect on the environment as the project is a minor alteration to land with only minimal grading and trenching involved; NOW, THEREFORE,

BE IT RESOLVED, that acceptance of funds for the Redesign of Saturn Boulevard and Rimbey Avenue Sidewalk Improvement Project is categorically exempt from CEQA pursuant to CEQA Guidelines section 15304.

BE IT FURTHER RESOLVED, that the Council of the City of San Diego has determined that an exception to the exemption as set forth in CEQA Guidelines section 15300.2 does not apply.
