DATE OF FINAL PASSAGE MAY 29 2014

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO RATIFYING THE CONTRACT BETWEEN THE CITY OF SAN DIEGO AND T&T JANITORIAL, INC. FOR THE PURPOSE OF PROVIDING JANITORIAL SERVICES FOR CITY COMFORT STATIONS PURSUANT TO BID NO. 10021966-12-L.

WHEREAS, on October 20, 2011, the City of San Diego (City) issued a comprehensive Request for Bids, Bid No. 10021966-12-L, for twenty-four hour janitorial maintenance services for the Civic Center and Gaslamp Square comfort stations; and

WHEREAS, the contract, which is a two (2) year contract with three (3) options to extend (commencing on December 31, 2011, and potentially extending until December 31, 2016), was awarded to T&T Janitorial, Inc. (Contract); and

WHEREAS, the City has exercised the first option of the Contract, and has determined that upon the exercise of the second option in fiscal year 2015, the total contract expenditures will exceed one million (\$1,000,000) dollars; and

WHEREAS, in order to avoid interruption of the Contract and the provision of needed janitorial services for the subject comfort stations, the Park and Recreation Department is now seeking the City Council's ratification of the Contract in compliance with San Diego Municipal Code §22.3206(c); NOW, THEREFORE,

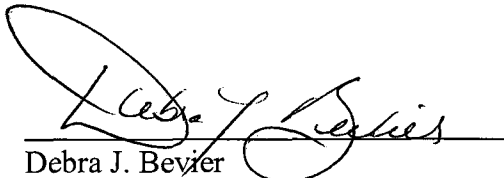
BE IT RESOLVED, by the Council of the City of San Diego that the Contract between the City of San Diego and T&T Janitorial, Inc., to provide twenty-four hour janitorial maintenance services for the Civic Center and Gaslamp Square comfort stations (Bid Number 10021966-12-L), is ratified to exceed one million (\$1,000,000) dollars.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$314,254 in Fiscal Year 2015, from the General Fund (100000), Park and Recreation Department (1714), contingent upon adoption of the Fiscal Year 2015 Annual Budget Appropriation Ordinance.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$329,967 in Fiscal Year 2016, from the General Fund (100000), Park and Recreation Department (1714), contingent upon adoption of the Fiscal Year 2016 Annual Budget Appropriation Ordinance.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$164,984 in Fiscal Year 2017, from the General Fund (100000), Park and Recreation Department (1714), contingent upon adoption of the Fiscal Year 2017 Annual Budget Appropriation Ordinance.


