WHEREAS, the Commission consists of seven members appointed by the Mayor, subject to Council confirmation; and

WHEREAS, members of this Commission serve for four-year terms and until their successors are elected, appointed, and qualified; and

WHEREAS, appointments to the Commission are to be made so that not more than three members are appointed in any one year; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the following appointments by the Mayor of the City of San Diego, to serve as members of the Planning Commission, for terms ending as indicated, are made and hereby confirmed:
