A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MISSION HILLS/HILLCREST BRANCH LIBRARY PRIVATE FUNDING.

WHEREAS, the San Diego Public Library Foundation has received commitments for a new 15,000 square feet Mission Hills/Hillcrest Branch Library [Library] to be located on the south side of Washington Street, between Front and Albatross Streets, north of Florence Elementary School; and

WHEREAS, the San Diego Public Library Foundation has received preliminary commitments from two donors for a total of \$10,000,000 for construction of the Library; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego as follows:

- 1. That the Mayor, or his designee, is authorized to negotiate and execute one or more agreements, for and on behalf of the City, and to accept and deposit up to \$10,000,000 in private donations into PRIVATE AND OTHER CONTRIB-CIP Fund No. 400264, for the construction of Mission Hills/Hillcrest Branch Library and project related costs, contingent upon the execution of the contribution agreement and receipt of funds.
- 2. That the Chief Financial Officer is authorized to increase the Capital Improvement Program Budget in CIP S-13022, Mission Hills/Hillcrest Branch Library and to appropriate and expend up to \$10,000,000 in donations from PRIVATE AND OTHER CONTRIB-CIP Fund No. 400264 for the purpose of project construction and related costs, and

contingent upon the execution of the contribution agreement and the City Comptroller demonstrating the funds are, or will be on deposit with the City Treasurer.

- 3. That the donor has the option to add to the name of the library in the following manner: Mission Hills/Hillcrest Harley and Bessie Knox Branch Library.
- 4. That the name designated by the donors is subject to approval by the Library Commission
