A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR, OR HIS. DESIGNEE, TO EXECUTE A SEVEN (7) YEAR LEASE BETWEEN THE CITY OF SAN DIEGO AND THE MENTAL HEALTH ASSOCIATION FOR THE USE OF THE PREMISES LOCATED AT 4069 30TH STREET.

WHEREAS, the Mental Health Association (MHA) has been serving the San Diego community with mental health outreach programs for more than seven (7) years, occupying the second floor of the City-owned building located at 4069 30th Street, San Diego; and

WHEREAS, MHA now seeks to lease all of the property, including the entire two-story building, located at 4069 30th Street, San Diego (Premises), for a seven (7) year term, in order to continue its mental health outreach programs and services; and

WHEREAS, City staff has negotiated proposed terms and conditions with MHA wherein MHA would annually pay the City \$3,250, adjusted annually for Consumer Price Index increases, reflecting the City's annual administrative costs involved with the lease; and MHA would be required to perform interior and exterior painting of the two-story building, resurfacing and striping of the parking lot, repair or replace the HVAC units, repair or replace roofing if necessary, and repair or replace electrical wiring as necessary; and

WHEREAS, Council Policy 700-12 provides that fair market value shall be obtained for leases of City-owned property to non-profit entities and that the only discount should be for direct offsets to otherwise-required City expenditures; and

WHEREAS, the market value of the subject real estate is approximately \$7,200 to \$8,000 per month; NOW, THEREFORE,

BE IT FURTHER RESOLVED, that given the health, social, educational, and other public benefits to be afforded by the Mental Health Association's use and occupancy of the Premises, Council Policy 700-12 is hereby waived to the extent that the City property shall be leased at less than fair market value.
