A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$40,000 TO SAN DIEGO WORKFORCE PARTNERSHIP FOR CONNECT2CAREERS PROGRAM, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, Council Policy 100-06, "City Council Funding of Community Projects,
Programs and Services" (CPPS), provides a procedure and uniform requirements for awarding
funds to and contracting with non-profit organizations and public agencies for one-time
community, social, environmental, cultural or recreational needs which serve a lawful public
purpose; and

WHEREAS, the San Diego Workforce Partnership has requested funding for the CONNECT2Careers program; and

WHEREAS, the requested funding will allow San Diego Workforce Partnership to place young people ages 16-21 in summer jobs and help them learn skills and careers in the region's most important industry clusters; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06, "Community Projects, Programs and Services;" and

WHEREAS, Council District 1 recommends an allocation of \$40,000 to San Diego Workforce Partnership for the purposes set forth herein allocated as follows: Council District 1 - \$20,000; Council District 4 - \$5,000; Council District 5 - \$5,000; Council District 6 - \$5,000; and Council District 7 - \$5,000; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described herein is made for a public purpose.

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, an Agreement with San Diego Workforce Partnership in an amount not to exceed \$40,000 for the project described herein, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR-308960

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$40,000 from the Community Projects, Programs and Services budget Fund No. 100000, as follows:

\$20,000 from Cost Center 1101110001

\$5,000 from Cost Center 1104110004

\$5,000 from Cost Center 1105110005

\$5,000 from Cost Center 1106110006

\$5,000 from Cost Center 1107110007

to provide funds for the above-referenced agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit in the City Treasury.
