A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$5,000 TO COMMON GROUND THEATRE FOR "A 50TH ANNIVERSARY PRODUCTION SHOWCASE," PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, Council Policy 100-06, "City Council Funding of Community Projects,
Programs and Services" (CPPS), provides a procedure and uniform requirements for awarding
funds to and contracting with non-profit organizations and public agencies for one-time
community, social, environmental, cultural or recreational needs which serve a lawful public
purpose; and

WHEREAS, Common Ground Theatre has requested funding for "A 50th Anniversary Production Showcase"; and

WHEREAS, the requested funding will be used for expenses of the production which will help Common Ground Theatre raise money to continue to offer free or reduced cost theatre arts classes to students who are recruited primarily from the economically impacted areas of Council Districts 4 and 8; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06, "Community Projects, Programs and Services;" and

WHEREAS, Council District 4 recommends an allocation of \$5,000 to Common Ground Theatre for the purposes set forth herein; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described herein is made for a public purpose.

BE IT FURTHER RESOLVED, that the Council hereby waives Council Policy 100-06,

3(g), which provides: "An organization may not apply to receive funding for an event or program

which has already occurred, nor any capital improvement, goods, supplies, materials, or

equipment which have already been purchased," and the statement in Council Policy 100-06 that

funds shall not be used for fundraising activities, to the extent it may be applicable.

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and

directed to execute, for and on behalf of the City, an Agreement with Common Ground Theatre

in an amount not to exceed \$5,000 for the project described herein, under terms and conditions

set forth in the Agreement on file in the Office of the City Clerk as Document No. RR-

308979

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend

an amount not to exceed \$5,000 from the Community Projects, Programs and Services budget

Fund No. 100000, Cost Center 1104110004, to provide funds for the above-referenced

agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates

certifying that the funds necessary for expenditure are, or will be, on deposit in the City

Treasury.
