A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$15,000 TO CESAR CHAVEZ SERVICE CLUBS FOR THE CESAR CHAVEZ COMMUNITY SERVICE PROGRAM, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, Council Policy 100-06, "City Council Funding of Community Projects, Programs and Services" (CPPS), provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural or recreational needs which serve a lawful public purpose; and

WHEREAS, Cesar Chavez Service Clubs has requested funding for the Cesar Chavez Community Service Program; and

WHEREAS, the requested funding will allow Cesar Chavez Service Clubs and its student school clubs to provide tree planning, landscape repair, litter pick-up, graffiti clean-up, cleaning, and painting to restore the health and beauty of neighborhood facilities; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06, "Community Projects, Programs and Services;" and

WHEREAS, Council District 9 recommends an allocation of \$15,000 to Cesar Chavez Service Clubs for the purposes set forth herein attributed as follows: Council District 4 - \$2,500; Council District 8 - \$2,500; and Council District 9 - \$10,000; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described herein is made for a public purpose.

BE IT FURTHER RESOLVED, that the Council hereby waives Council Policy 100-06, 3(g), which provides: "An organization may not apply to receive funding for an event or program which has already occurred, nor any capital improvement, goods, supplies, materials, or equipment which have already been purchased."


BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, an Agreement with Cesar Chavez Service Clubs in an amount not to exceed \$15,000 for the project described herein, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR- 308985.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$15,000 from the Community Projects, Programs and Services budget Fund No. 100000, as follows:

\$2,500 from Cost Center 1104110004
\$2,500 from Cost Center 1108110008
\$10,000 from Cost Center 1109110009

to provide funds for the above-referenced agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit in the City Treasury.




