A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO CONFIRMING THE FISCAL YEAR 2015  
BUDGET REPORTS FOR SPECIFIED BUSINESS  
IMPROVEMENT DISTRICTS AND LEVYING ANNUAL  
ASSESSMENTS.

WHEREAS, in accordance with the Parking and Business Improvement Area Law of 1989 (California Streets and Highways Code sections 36500, et seq.), the eighteen Business Improvement Districts identified below (Districts) were formed in the City of San Diego to levy assessments annually to pay for certain improvements and activities within the Districts; and

WHEREAS, the City Council, in accordance with the Parking and Business Improvement Area Law of 1989 (California Streets and Highways Code sections 36500, et seq.) and City Council Policy 900-07, wishes to continue the improvements and activities of the Districts; and

WHEREAS, the respective advisory board for each of the following Districts has submitted a report (Budget Report) for the period of July 1, 2014 through June 30, 2015 (Fiscal Year 2015), as required by California Streets and Highways Code sections 36533: Adams Avenue; City Heights; College Area; Diamond; Downtown; East Village; El Cajon Boulevard Central; El Cajon Boulevard Gateway; Gaslamp; Hillcrest; La Jolla; Little Italy; Mission Hills; North Park; Ocean Beach; Old Town; Pacific Beach; and San Ysidro; and

WHEREAS, on MAY 20, 2014, the City Council adopted Resolution No. R- 308990, in which the City Council approved the Fiscal Year 2015 Budget Reports for each of the specified Districts; and

WHEREAS, beginning in Fiscal Year 2014, in an effort to streamline the annual appropriation process, the City Council authorized entering into five-year operating agreements with the associations that administer the Districts; and

WHEREAS, in Fiscal Year 2015, the Districts will continue to be administered by those associations pursuant to the five-year operating agreements; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, as follows:


1. The Fiscal Year 2015 Budget Reports for the specified Districts in the City of San Diego, as further described in paragraph 2 of this Resolution, are hereby confirmed.

The City's Chief Financial Officer or designee is authorized to appropriate, transfer, and expend assessment revenues within each District's fund for administration and operation of that District in accordance with the approved Fiscal Year 2015 Budget Reports, including the Fund Balance and Interest Fund Balance from Fiscal Year 2014 at year end and the anticipated District assessments to be collected in Fiscal Year 2015.


