

RESOLUTION NUMBER R- 309025DATE OF FINAL PASSAGE JUN 23 2014A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO CONFIRMING APPOINTMENTS TO THE
BOARD OF BUILDING APPEALS AND ADVISORS

WHEREAS, San Diego Municipal Code section 111.0207 governs the City's Board of Building Appeals and Advisors (the Board); and

WHEREAS, the Board is tasked with investigating and advising as to the suitability of using any alternate material, design or construction method for buildings; recommending reasonable interpretations of the provisions of the building code; and conducting public hearings on the passage of new legislation pertaining to the design and construction of buildings and making related recommendations to the City Council; and

WHEREAS, the Municipal Code provides that the Board will have 10 members, who are to be appointed by the Mayor and confirmed by the City Council; and

WHEREAS, the Municipal Code requires that designated members have experience and training in matters of design and construction of buildings, fire prevention and fire protection; and


WHEREAS, the Municipal Code provides that at least two members shall be licensed by the State of California as civil engineers, one of whom is duly authorized to use the title "structural engineer;" one member each shall be from the electrical and mechanical industries or professions; at least two members shall be licensed by the State of California as fire protection engineers; at least one member shall be licensed by the State of California as an architect; and at least one member shall represent the disabled community; and

WHEREAS, members are to serve two-year terms and each member shall serve until a successor is duly appointed and confirmed, terms expire on March 1, and not more than five terms shall expire in any year; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the following appointment and reappointments by the Mayor of the City of San Diego, to serve as members of the Board of Building Appeals and Advisors, for terms expiring as indicated, are made and hereby confirmed:
