A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING AN AMENDMENT TO THE AGREEMENT WITH COLLABORATIVE SERVICES FOR WATER CONSERVATION OUTREACH.

WHEREAS, California Governor Jerry Brown, along with the Metropolitan Water

District Board of Directors and the City Council, has declared a Level 1 drought watch for the

City of San Diego region after declaring a Water Supply Alert due to the state's unprecedented

dry conditions; and

WHEREAS, the City Council passed Resolution R-306250 on October 19, 2010, authorizing execution of an Agreement with Collaborative Services, Inc., for \$600,000 for three years not to exceed \$200,000 per year, and also authorized options to renew the Agreement for two (2) additional one (1) year periods also at \$200,000 per year, thus approving a total of \$1,000,000 over five (5) years; and

WHEREAS, the Environmental Committee on May 21, 2014, approved amending the Agreement with Collaborative Services, Inc., to add \$100,000 for professional services in water conservation outreach, public information and education campaign, and drought response for the First Option Year, Fiscal Year 2014-2015; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego as follows:

1. That the Mayor, or his designee, is authorized to execute, for and on behalf of the City, the First Amendment with Collaborative Services Inc., Contract No. 4600000395, increasing the amount of expenditure in the First Option Year (Fiscal Year 2014-2015) by \$100,000, for a First Option Year (Fiscal Year 2014-2015) contract total not to exceed \$300,000,

from Water Utility Operating Fund 700011, for professional services for water conservation public information, education, outreach, and drought response, under the terms and conditions set forth in the First Amendment, on file in the Office of the City Clerk as Document No. RR-309041.

2. That the Chief Financial Officer is authorized to expend an additional amount not to exceed \$100,000, for a First Option Year (Fiscal Year 2014-2015) contract total not to exceed \$300,000, from Water Utility Operating Fund 700011, solely and exclusively to provide funds for the above First Amendment, provided that the City Comptroller first furnishes one or more certificates demonstrating that the funds necessary for this expenditure are, or will be, on deposit with the City Treasurer.
