A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO AMENDING COUNCIL POLICY NO. 100-02  
REGARDING CITY RECEIPT OF DONATIONS.

WHEREAS, in 1964, the City Council adopted a resolution creating Council Policy No. 100-02, titled "City Receipt of Donations," which is on file in the Office of the City Clerk and incorporated in the City's Council Policy Manual; and

WHEREAS, Council Policy No. 100-02 provides criteria and principles to guide the review and acceptance of donations to the City; and

WHEREAS, Council Policy No. 100-02 was last amended in 1994 and staff recommends updating the policy to provide guidelines for accepting gifts and donations in a responsible, transparent and accountable manner that is consistent with the City's strategic goals;

NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that Council Policy No. 100-02, now titled "Donation Acceptance," is revised as set forth in the Council Policy filed in the Office of the City Clerk as Document No. RR- 309042.

BE IT FURTHER RESOLVED, that the City Clerk is instructed to add the amended Council Policy 100-02 to the Council Policy Manual.


