WHEREAS, under the Mayor-Council form of governance, the Board is advisory to the Mayor, and through the Mayor to the City Council, on all questions of library policy; and

WHEREAS, the Board consists of seven members, who serve two-year terms and until their successors are appointed and qualified; and

WHEREAS, the expiration date of all Board terms is March 1, and not more than four terms shall expire in any year; and

WHEREAS, during March of each year, the Mayor may designate one member as Chair; however, in the absence of such designation, the Board shall, on or after April 15, select a Chair from among its members; and

WHEREAS, Municipal Code section 26.0301 provides that, during the time that the San Diego Unified School District (the District) leases space at the Central Library for a school or school-related purposes, and as required by the terms of the lease, one member of the Board shall be an official representative of the District; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the following appointment and reappointments by the Mayor of the City of San Diego, to serve as members of the Board of Library Commissioners, for terms expiring as indicated, are made and hereby confirmed:
