DATE OF FINAL PASSAGE JUN 25 2014

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE ESTABLISHMENT OF A NEW FEE FOR A TEMPORARY OVERNIGHT RECREATIONAL VEHICLE PARKING PERMIT TO BE INCLUDED IN THE RATEBOOK OF CITY FEES AND CHARGES MAINTAINED IN THE OFFICE OF THE CITY CLERK.

WHEREAS, on July 23, 2013, City Council adopted Ordinance No. O-20281, which among other things established a permit process for temporary overnight parking of recreational vehicles on public streets; and

WHEREAS, this permit process is codified in San Diego Municipal Code sections 86.0138 through 86.0143; and

WHEREAS, pursuant to San Diego Municipal Code section 86.0142(g), the fee for obtaining this Temporary Overnight Recreational Vehicle Parking Permit shall be established by a resolution of the City Council based upon the recommendation of the Mayor or his designee; and

WHEREAS, under Council Policy 100-05 entitled "User Fee Policy", all user fees are assumed to be Category I fees at 100 percent cost recovery, unless they meet the criteria for other Categories under this policy; and

WHEREAS, based on the analysis conducted by the Office of the City Treasurer of reasonably anticipated direct and indirect costs associated with the issuance of a Temporary

Overnight Recreational Vehicle Parking Permit, City staff recommends that the fee be set at essentially 100 percent cost recovery at \$1.25 per permit; and

WHEREAS, San Diego Municipal Code sections 86.0138 through 86.0142 involving temporary overnight parking permits for recreational vehicles on public streets is not yet in effect because San Diego Municipal Code section 86.0143 conditioned the effectiveness of these Municipal Code sections upon certification by the California Coastal Commission (Commission); and

WHEREAS, the Commission has now indicated that it does not need to approve or otherwise certify San Diego Municipal Code sections 86.0138 through 86.0142; and


WHEREAS, as a result of the Commission's position, the City Attorney is bringing forward a separate Ordinance No. O- **20382** (City Att'y Ordinance No. O-2014-114), for approval of the City Council which will amend San Diego Municipal Code section 86.0143 by deleting any need for Commission approval so that the provisions of San Diego Municipal Code sections 86.0138 through 86.0142 can go into effect; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the fee of \$1.25 is adopted for the purpose of recovering costs incurred by the City of San Diego in issuing each Temporary Overnight Recreational Vehicle Parking Permit.
2. That the Temporary Overnight Recreational Vehicle Parking Permit fee shall be effective upon the effective date of Ordinance No. O- **20382**

3. That the City Clerk is directed to amend the Ratebook of City Fees and Charges maintained in the Office of the City Clerk to include the fee described above.


