DATE OF FINAL PASSAGE JUN 25 2014

A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO AUTHORIZING THE RENEWAL FOR THE  
LANDSCAPE CONTRACT WITH AZTEC LANDSCAPING  
FOR MIRA MESA AND CALLE CRISTOBAL  
MAINTENANCE ASSESSMENT DISTRICTS FOR SERVICES  
IN EXCESS OF \$1 MILLION.

WHEREAS, the City of San Diego's Park and Recreation Department, Open Space Division, currently administers 50 of the 57 Maintenance Assessment Districts located throughout the City, including the Mira Mesa Maintenance Assessment District and the Calle Cristobal Maintenance Assessment District (collectively, Districts); and

WHEREAS, the Mira Mesa Maintenance Assessment District was established in July 1983, per Resolution R-258898, and the Calle Cristobal Maintenance Assessment District was established in July 1987, per Resolution R-268907, to provide landscape maintenance services; and

WHEREAS, the City Council last authorized approval of updated assessment engineer's reports and annual levy of assessments for the Districts on July 16, 2013, per Resolution R-308364; and

WHEREAS, the Districts maintain landscape and hardscape medians, parkways, and undeveloped open space; and

WHEREAS, all landscape maintenance activities in the Districts are provided by a landscape contractor; and

WHEREAS, the landscape activities and areas of maintenance in the Districts include care and cleaning of street medians, parkway landscaping, sidewalk, curb and gutter, landscaped slopes, mini-parks, greenbelts, and open space areas; and

WHEREAS, regular maintenance tasks in the Districts include litter removal, sweeping, edging, trimming, weeding, and related functions; and

WHEREAS, the City awarded and executed Contract No. 10024288-13-W (Contract) with Aztec Landscaping for landscape maintenance services within the Districts, having an initial term of one year commencing on March 1, 2013, with up to four one-year contract extension options; and

WHEREAS, the Contract is phase funded, with authority granted for each phase contingent upon the City Council's approval of future appropriation ordinances and assessment levies and with a maximum expenditure threshold of \$1 million; and

WHEREAS, it is anticipated that the maximum expenditure threshold of \$1 million for the Contract will be exceeded in Fiscal Year 2015; and

WHEREAS, this action will authorize exceeding the \$1 million threshold over the remainder of the five-year period in accordance with San Diego Municipal Code section 22.3211(d) and authorize the expenditure of funds, contingent upon the City Council authorizing the levy of assessments within the Districts and adopting the annual appropriation ordinance for each fiscal year of the Contract; and


WHEREAS, the Contract constitutes a contract or task order extended on or after January 1, 2014, such that the City shall require compliance with California Labor Code sections 1770 – 1781 (state prevailing wage laws) pursuant to Chapter 2, Article 2, Division 30 of the San Diego Municipal Code; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. The Mayor or his designee is authorized to exercise, and execute for and on behalf of the City, up to four one-year contract extension options with Aztec Landscaping as may be available pursuant to the Contract, subject to an amendment reflecting that state prevailing wage laws now apply to the Contract, and contingent upon adoption of the resolution authorizing the levy of assessments within the Districts and the Annual Budget Appropriation Ordinance for the applicable fiscal year, and contingent upon certification that the funds necessary for expenditure are, or will be, on deposit in the City Treasury.

2. The Chief Financial Officer is authorized and directed to expend an amount not to exceed \$3,269,436.53 over five years from Funds Nos. 200045 and 200037, Mira Mesa Maintenance Assessment District and Calle Cristobal Maintenance Assessment District, for the purpose of funding the Contract, contingent upon adoption of the resolution authorizing the levy of assessments within the Districts and the Annual Budget Appropriation Ordinance for the applicable fiscal year, and contingent upon certification that the funds necessary for expenditure are, or will be, on deposit in the City Treasury.
