A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE CITY OF SAN DIEGO'S
ECONOMIC DEVELOPMENT STRATEGY FOR 2014 – 2016

WHEREAS, Council Policy 900-01, Economic Development, and the City's General Plan both call for the preparation, consideration and adoption of a focused Economic Development Strategy every three years; and

WHEREAS, the Mayor has prepared the Economic Development Strategy 2014-2016 (Economic Development Strategy) for the City Council's consideration, relying upon academic studies, existing City land use plans, and Council Policy 900-01, and after seeking and receiving comprehensive public input from stakeholders such as businesses, business organizations, academia, the military, organized labor, and community groups; and

WHEREAS, the Council Committee on Economic Development and Intergovernmental Relations has recommended approval of the Economic Development Strategy; and

WHEREAS, the purposes of the Economic Development Strategy are described in Report to the City Council No. 13-098; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. The Council accepts the Economic Development Strategy and finds that it represents the City's plan for achieving economic growth and fiscal stability for the period of 2014 through 2016.

2. The Council authorizes the Mayor or his designee to implement the Economic Development Strategy.

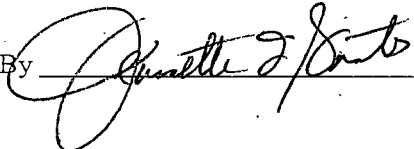
