A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE SETTLEMENT BETWEEN CITY OF SAN DIEGO, A MUNICIPAL CORPORATION AND SAN DIEGO AUTO CONNECTION, INC.

WHEREAS, on April 25, 2011, SAN DIEGO AUTO CONNECTION, INC., filed a cross-complaint against the City of San Diego [the City], alleging that the City had breached agreements entered into between the City and San Diego Auto Connection [SDAC] for use of the Qualcomm Stadium parking lot for auto and RV sales events. SDAC filed its cross-complaint in the San Diego Superior Court in an action filed by the City entitled *City of San Diego v. San Diego Auto Connection, Inc.*, et al.: SDSC, Case No 37-2011-00090135-CU-BC-CTL [the Litigation]; and

WHEREAS, in Closed Session on June 10, 2014, the City Council, by the following votes: Yeas, District(s) 1, 2, 4, 5, 6, 7); Nays, None; and absent, (District(s) 3, 8, 9; approved a settlement between the City and SDAC as to all claims asserted by either party in the Litigation.

WHEREAS, the City Council in closed session on June 10, 2014, authorized settlement of the Litigation for an amount consistent with the amounts set forth below; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the Council authorizes:

1. The Mayor or his designee to pay the sum of \$387,500.00 from the Public Liability Fund, Fund No. 720045, in settlement of each and every claim for contractual damages, interest, costs and fees of any type, including attorney fees, against the City, its agents and employees, arising from the Litigation.

- 2. The Chief Financial Officer to appropriate and expend \$387,500.00 from the Public Liability Fund 720045, contingent upon the Chief Financial Officer first furnishing one or more Certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
- 3. The Comptroller to issue a check in the amount of \$387,500.00, made payable to "San Diego Auto Connection, Inc."
