A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE SETTLEMENT BETWEEN JANICE CARLSON AND THE CITY OF SAN DIEGO

WHEREAS, on July 19, 2013, Plaintiff Janice Carlson filed suit against the City of San Diego [City] alleging personal injuries arising from an incident which occurred on March 4, 2013. The suit is entitled *Janice Carlson v. City of San Diego, et al.*, San Diego Superior Court Case No. 37-2013-00058455-CU-PO-CTL [Litigation]; and

WHEREAS, in Closed Session on June 17, 2014, the City Council, by the following votes:

Yeas, Districts 1, 2, 3, 4, 5, 6, 7; Nays, None; and Absent, Districts 8 and 9; and

WHEREAS, the City Council in Closed Session on June 17, 2014, authorized settlement of the Litigation for an amount consistent with the amounts set forth below; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council authorizes:

1. The Mayor or his designee to pay the sum of \$137,500 from the Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the personal injury claim of Janice Carlson, San Diego Superior Court Case No.. 37-2013-00058455-CU-PO-CTL.

- 2. The Chief Financial Officer to appropriate and expend \$137,500 from the Public Liability Fund, Fund 720045, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
- 3. The Comptroller to issue a check in the amount of \$137,500, made payable to Dicks & Workman Client Trust Account for Janice Carlson.
