DATE OF FINAL PASSAGE JUL 30 2014

A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO INCREASING THE MAXIMUM EXPENDITURE
AMOUNT FOR THE CONTRACT WITH HAAKER
EQUIPMENT COMPANY FOR PURCHASE OF SEWER MAIN
CLEANING TRUCKS; AND TAKING RELATED ACTIONS.

WHEREAS, pursuant to Resolution R-308229, the City Council authorized a contract with Haaker Equipment Company, RFB No. 10023129-13-E, a copy of which is on file as Document No. RR-308229 (Haaker Contract), for the purchase of sewer main cleaning trucks in order to replace the vehicles currently used by the Public Utilities Department, Wastewater Collection Division (Department) in cleaning and maintaining the wastewater collection pipeline system; and

WHEREAS, the Haaker Contract allowed the Department to purchase up to twenty sewer main cleaning trucks over a five-year period for an estimated cost of \$10 million, but the estimated cost is more accurately over \$11 million; NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the authorization granted to the Mayor or his designee pursuant to Resolution R-309229 to purchase sewer main cleaning trucks from Haaker Equipment Company in quantities as may be required over a five-year period is hereby amended to increase the total maximum cumulative expenditure amount under the Haaker Contract to \$11,501,671.

2. That the Chief Financial Officer's authorization to appropriate and expend funds pursuant to Resolution R-309229 is hereby amended to increase such appropriation and expenditure authority to a total cumulative amount not to exceed \$11,501,671 from Fund 720013, Vehicle Replacement Fund over the five year period, contingent upon the adoption

of the Annual Appropriation Ordinance for each fiscal year and the Chief Financial Officer first furnishing one or more certificates demonstrating that the funds for the expenditure are, or will be, on deposit with the City Treasury.


