A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE SETTLMEENT IN *CATHY LEXIN, ET AL. V. CITY OF SAN DIEGO*, SAN DIEGO SUPERIOR COURT CASE NO. 37-2011-00100142-CU-MC-CTL

WHEREAS, the City Council adopted Resolution R-297335 in November 2002, wherein the City agreed to "defend, indemnify and hold harmless all past, present and future members of the Retirement Board against all expenses, judgments, settlements, liability and other amounts actually and reasonably incurred by them in connection with any claim or lawsuit arising from any act or omission in the scope of the performance of their duties as Board Members under the Charter;" and

WHEREAS, Cathy Lexin, Ronald Saathoff and Teresa Webster incurred attorney's fees and costs in defense of federal fraud and conspiracy charges filed in January 2006. The charges stemmed from their approval of an agreement to modify the City's annual pension contribution amount, known as "Manager's Proposal 2" or "MP2," while members of the San Diego City Employees' Retirement System's Board of Administration; and

WHEREAS, the federal charges were dismissed in 2010; and

WHEREAS, Resolution No. R-297335 was held to authorize payment and indemnification of criminal defense fees and costs in a companion case (*Lexin, et al., v. City of San Diego*, 222 Cal. App. 4th 662 (2013)); and

WHEREAS, in Closed Session on April 29, 2014, the City Council approved the settlement, by the following vote: Yeas – District(s) 1, 2, 3, 4, 5, 6, 7, and 8; Nays – None; Absent – District 9; and NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council:

- 1. Authorizing the Mayor or his designee to pay the sum of \$1,182,138.36 from the Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the indemnification claims in *Lexin*, et al. v. City of San Diego, San Diego Superior Court Case No. 37-2011-00100142-CU-MC-CTL; and
- 2. Authorizing the Chief Financial Officer to appropriate and expend the sum of \$1,182,138.36 from the Public Liability Fund No. 720045, contingent upon the Comptroller first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer; and
- 3. Authorizing the Comptroller to issue a check in the amount of \$549,231.45, made payable to the Gibson, Dunn & Crutcher LLP Trust Account for Cathy Lexin; and
- 4. Authorizing the Comptroller to issue a check in the amount of \$205,320.55, made payable to the Coughlan, Semmer, Fitch & Pott, LLP State Bar of California Attorney Client Trust Account for Ronald Saathoff; and

5. Authorizing the Comptroller to issue a check in the amount of \$427,586.36, made payable to the Frank T. Vecchione Client Trust Account for Terri A. Webster.
