DATE OF FINAL PASSAGE AUG 11 2014

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO  
AUTHORIZING THE EXECUTION OF A CONTRACT FOR CITYWIDE  
TREE MAINTENANCE SERVICES IN THE STREET RIGHTS-OF-WAY.

WHEREAS, the City desires to perform maintenance of trees located within the public  
right-of-way; and

WHEREAS, the City issued an Invitation to Bid (ITB 10046800-15-E), and has selected  
Atlas Environmental Services to enter into an agreement to perform tree maintenance for the  
City's street rights-of-way [ROW Tree Maintenance]; NOW, THEREFORE

BE IT RESOLVED, by the Council of the City of San Diego as follows:


1. That the Mayor, or his designee, is authorized to execute, for and on behalf of the  
City, a contract, terms and conditions set forth in the Agreement, on file in the Office of the City  
Clerk as Document No. RR 309161, with Atlas Tree Service to provide As-Needed tree  
services within the City right-of-way, having an initial term of one year for an amount not to  
exceed \$2,601,025, of which \$2,381,008 is from Fund 100000 – General Fund, and \$220,017 is  
from Fund 200217 – Underground Surcharge Fund, contingent upon the City's Chief Financial  
Officer, or their designee, first certifying that funds are or will be on deposit with the City  
Treasurer.

2. That the Mayor, or his designee, is authorized to exercise, for and on behalf of the  
City, up to four one-year contract extension options, for a total contract amount not to exceed  
\$13,005,125 for a five year period, for the purpose of funding As-Needed tree services with City  
right-of-way, contingent upon adoption of the annual Appropriation Ordinance for the applicable  
fiscal year and provided that the Chief Financial Officer provided first furnishes one or more

certificates certifying that the funds necessary for expenditures are, or will be, on deposit with the City Treasury.

3. That the Chief Financial Officer is authorized to expend an amount not to exceed \$11,905,040 in total from Fund 100000 – General Fund, and \$1,100,085.00 from Fund 200217 – Underground Surcharge Fund, contingent upon the adoption of the FY15 Budget Appropriation Ordinance and each subsequent applicable fiscal year, and provided that the Chief Financial Officer first furnishes one or more certificates that the funds necessary for expenditure are, or will be, on deposit in the City Treasury.


