A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DETERMINING THAT THE APPROVAL OF A CITYWIDE TREE SERVICES CONTRACT IS CATEGORICALLY EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT PURSUANT TO CEQA GUIDELINES SECTION 15301 "EXISTING FACILITIES."

WHEREAS, this action considers the environmental impact of a contract to maintain trees in the public right-of-way; and

WHEREAS, this contract for tree maintenance services is on file in the Office of the City Clerk as Document No. RR. 309161

WHEREAS, the California Environmental Quality Act (CEQA), Public Resources Code section 21084, states that the CEQA Guidelines shall list those classes of projects which have been determined not to have a significant effect on the environment and which shall be exempt from CEQA; and

WHEREAS, pursuant to that authority, CEQA Guidelines sections 15300 through 15333 list the categorical exemptions promulgated by the California Office of Planning and Research for those classes of projects which have been determined not to have a significant effect on the environment; and

WHEREAS, the Council of the City of San Diego, using its independent judgment, has determined that the project will not have a significant effect on the environment as the scope of work for this contract will be limited to maintenance and minor alteration of existing trees within the City's public right-of-way; NOW, THEREFORE,

BE IT RESOLVED, that the citywide tree services contract is categorically exempt from CEQA pursuant to CEQA Guidelines section 15301 "Existing Facilities."

BE IT FURTHER RESOLVED, that the Council of the City of San Diego has determined that an exception to the exemption as set forth in CEQA Guidelines section 15300.2 does not apply.

BE IT FURTHER RESOLVED, that the City Clerk is directed to file a Notice of Exemption regarding the project with the Clerk of the Board of Supervisors for the County of San Diego.
