A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO CONFIRMING APPOINTMENTS TO THE
ABANDONED VEHICLE ABATEMENT SERVICE
AUTHORITY FOR THE REMAINDER OF CALENDAR
YEAR 2014.

WHEREAS, each year the City appoints elected officials to serve as representatives, alternates and liaisons to various outside boards, commissions, committees, and governmental agencies; and

WHEREAS, a review of the various boards, commissions, committees and governmental agencies to which the City appoints representatives confirms that some appointments of elected officials as City representatives may be accomplished by the Mayor alone, or by the Mayor and City Council acting jointly; and

WHEREAS, on December 17, 2013, the Council confirmed appointments of elected officials to serve as the City's representatives, alternates, and liaisons for the calendar year 2014, as reflected in Resolution No. R-308692; and

WHEREAS, additional appointments for the remainder of calendar year 2014 are now appropriate; and


WHEREAS, the Council President has appointed Councilmember Lorie Zapf and Councilmember David Alvarez to serve as representatives on the Abandoned Vehicle Abatement Service Authority for the remainder of calendar year 2014, subject to confirmation by a majority vote of the Council; and

WHEREAS, the City has adopted and posted on its website the Fair Political Practices Commission Form 806 listing the proposed public official appointments; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the following appointments of elected officials as representatives of the Abandoned Vehicle Abatement Service Authority, to serve through December 2014, and until a successor is duly appointed and confirmed, are hereby confirmed:

- Councilmember David Alvarez – Representative




