2. The continued levy and collection of assessments on parcels within the Citymanaged MADs is hereby authorized for Fiscal Year 2015 to pay a prescribed portion of the costs of improvements and/or services as described in each updated Engineer's Report.

3. The Chief Financial Officer is authorized to appropriate and expend MAD funds for Fiscal Year 2015, including the management fund, district operating funds, district capital funds, and developer deposit funds associated with new MAD formation activities for Fiscal Year 2015 contingent upon approval of the Fiscal Year 2015 Appropriation Ordinance and contingent upon the City Comptroller certifying that the funds necessary for expenditure are or will be available.
