A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO EXPRESSING SUPPORT FOR HOSTING THE  
35TH AMERICA'S CUP COMPETITION IN SAN DIEGO.

Whereas, the America's Cup is the oldest trophy in international sport and is the pinnacle of the sport of sailing; and

Whereas, the City of San Diego has a proud history with the America's Cup, having served as the Host City of the event for three previous defenses in 1988, 1992, and 1995; and

Whereas, San Diegans enthusiastically embraced the international competitions and many landmarks remain today that reflect the vibrancy the events brought to San Diego; and

Whereas, the Port of San Diego (the Port) has submitted a proposal to the America's Cup Event Authority highlighting the benefits San Diego would bring if it were to serve as the host venue for the 35<sup>th</sup> America's Cup, scheduled for the summer of 2017; and

Whereas, the Port's proposal includes the use of north San Diego Bay, which will bring entertainment and enjoyment to San Diegans and substantial economic benefits to San Diego; and


Whereas, the Port's proposal has achieved finalist status, and San Diego is now competing with Bermuda for selection as the host city; and

Whereas, San Diego's experience as a host city for major national and international events, combined with San Diego's world-class facilities and beautiful climate, make this an ideal site to host a competitive event of the highest caliber; and

Whereas, San Diego's resources and experience can become important components of the Port's proposal, leading to final selection; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Council actively supports the efforts of the Port of San Diego to secure San Diego's selection as the host city for 35th America's Cup, to be held in the summer of 2017.





