A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO AMENDING THE 2014 LEGISLATIVE

- Adding a meeting of the Smart Growth and Land Use Committee on November 20, 2014 at 2 p.m.;
- Adding a Council Meeting on December 10, 2014 at 10 a.m., for purposes of holding the City Council Inauguration Ceremony;
- Adding a Council Meeting on December 15, 2014 at 2 p.m.;
- Adding a Closed Session Meeting of the Council on December 15, 2014 at 9 a.m.;
- Adding a Council Meeting on December 16, 2014, at 10 a.m. and 2 p.m.;
- Adding a Housing Authority Meeting on December 16, 2014 at 2 p.m.; and

WHEREAS, under San Diego Charter section 280(a)(1) this resolution is not subject to veto by the Mayor, because this matter is exclusively within the purview of the City Council and not affecting the administrative service of the City under the control of the Mayor; NOW, THEREFORE,


