WHEREAS, the City of San Diego (City), has determined that it is in the public interest and for the public benefit that the City become a Member of the Authority in order to facilitate the promotion of economic, cultural and community development activities in the City, including the financing of projects by the Authority; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego as follows:

Section 1. The Agreement is hereby approved and the Mayor, Chief Operating Officer, Chief Financial Officer and each of his or her respective designees is authorized and directed to execute the Agreement for and on behalf of the City.

Section 2. The Mayor, Chief Operating Officer, Chief Financial Officer and each of his or her respective designees are hereby authorized and directed to execute such other agreements, documents and certificates, and to perform such other acts and deeds, as may be

necessary or convenient to effect the purposes of this Resolution and the transactions herein authorized.

Section 3. The Clerk shall forward a certified copy of this Resolution and an originally executed Agreement to the Authority in care of its counsel:
