A RESOLUTION AUTHORIZING THE CITY ATTORNEY TO RETAIN HAIGHT, BROWN & BONESTEEL LLP FOR LEGAL SERVICES IN CONNECTION WITH DAVIS ET AL. V. CITY OF SAN DIEGO, ET AL. (USDC 14CV1488 DMS (DHB)), AND RELATED CASES, FOR THE DEFENSE OF FORMER SAN DIEGO POLICE OFFICER CHRISTOPHER HAYS

WHEREAS, the City Council has determined that a conflict of interest exists between the City of San Diego and former San Diego Police Officer Christopher Hays; and

WHEREAS, former San Diego Police Officer Christopher Hays and the City of San Diego have been sued in the case *Michelle Davis, Nicole Johnson and Claudia Ariza v. The City of San Diego and Christopher Hays*, (USDC 14 CV1488 DMS(DHB) for federal law claims;

WHEREAS more Plaintiffs are expected to file lawsuits against Christopher Hays and the City of San Diego for federal law claims;

WHEREAS, on July 1, 2014, the City Council in closed session, by a vote of 9-0 authorized the City Attorney's office to bring to Open Session a legal services agreement between the City of San Diego and Haight Brown & Bonesteel LLP in connection with the defense of the civil litigation against Mr. Hays for an amount up to \$250,000.00 in legal fees and costs;

NOW, THEREFORE, BE IT RESOLVED, that the Chief Financial Officer is authorized and empowered to execute, for and on behalf of the City, an agreement with Haight, Brown & Bonesteel LLP for the purposes of the defense of the civil litigation against Mr. Hays, for an

amount up to \$250,000.00 from the Public Liability Fund 720045, solely and exclusively for the purpose of providing funds for the above-described legal services and litigation expenses.

BE IT FURTHER RESOLVED that the Chief Financial Officer is authorized and empowered to appropriate up to \$250,000.00 from the Public Liability Fund to meet this obligation.
