BE IT RESOLVED, by the Council of the City of San Diego that the Council authorizes:

- 1. The Mayor or his designee to pay the sum of \$64,515.00 from the Water Utility Operating Fund, Fund 700011, in settlement of each and every claim for damages, interest, costs and fees of any type, including but not limited to attorneys fees, against the City of San Diego, its agents and employees resulting from the property damage claim of Richard Mursinna.
- 2. Authorizing the Chief Financial Officer to expend the amount of \$64,515.00 from the Water Utility Operating Fund 700011, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer, and upon the adoption of the fiscal year Annual Appropriations Ordinance.
