BE IT RESOLVED, by the City Council of the City of San Diego, that the council authorizes:

- 1. Authorizing the Mayor or his designee to pay the sum of \$180,000.00 from the Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the personal injury claim of Guadalupe Pomposo v. City of San Diego, et al., San Diego Superior Court Case No. SDSC 37-2013-00071618-CU-PA-CTL.
- 2. Authorizing the Chief Financial Officer to appropriate and expend \$180,000.00 from the Public Liability Fund, Fund 720045, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
